We find it is more common for members to seek advice from websites, followed by personal connections.

- 1. Websites MPFA, MPF providers and other financial websites: 37.4%
- 2. Personal connections family, friends and colleagues: 35.0%
- 3. MPF agents individuals or financial institutions: 30.5%
- 4. No advice sought 27.1%
