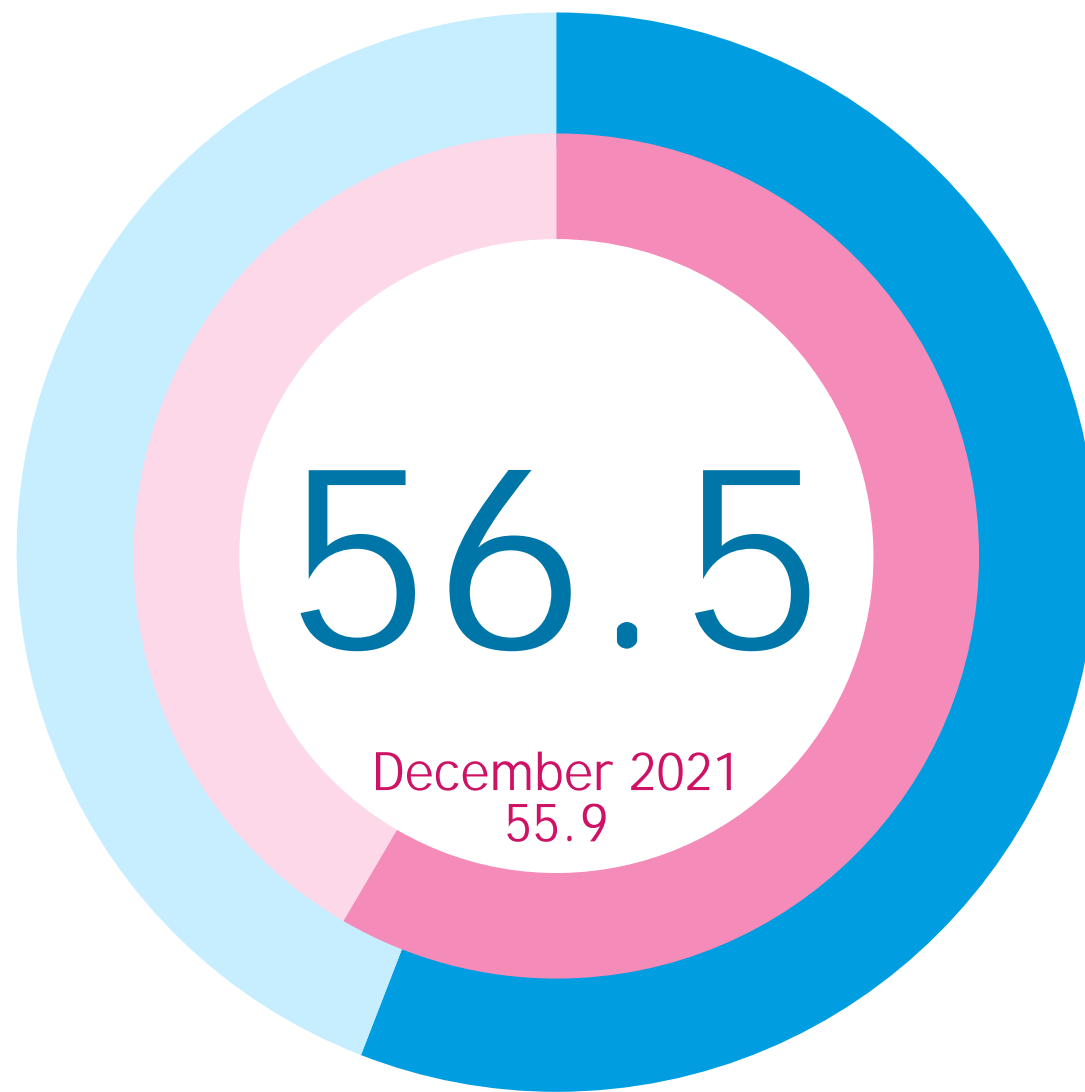

In the past 12 months, where have people sought help?

We find it is more common for members to seek advice from personal connections, followed by MPF agents.

- Personal connections — family, friends and colleagues: 42.0%
- Websites — MPFA, MPF providers and other financial websites: 38.5%
- MPF agents — individuals or financial institutions: 36.5%
- No advice sought: 24.0%
