

In the past 12 months, where have people sought help?

We find it is more common for members to seek advice from personal connections, followed by MPF agents.

- Personal connections family, friends and colleagues: 41.5%
- Websites MPFA, MPF providers and other financial websites: 36.0%
- MPF agents individuals or financial institutions: 26.5%
- No advice sought: 33.0%
